Gaming After Hours Rules, Policies & General Information

Registration for this event is **due no later than Monday, February 21, 2022**. Registration for this event is open to Grades 7–12.

PLEASE NOTE: a signed permission slip is required for each participant (see next page).

- All participants are required to check-in on the night of the event. ONLY a parent, legal guardian or pre-designated adult will be allowed to sign out each child at the end of the evening.
- Drop off and pick up of your child will be in the east parking lot entrance.
- Program participants will not be allowed to leave the Library at any time. If this rule
 is broken, the participant's parent or legal guardian will be called and must pick up
 their child.
- Participants must be respectful of others (including staff, volunteers, and all other participants) and their physical boundaries and of the Library building.
- Currently, masks are required to be worn indoors. When eating snacks, participants must maintain a distance of 3 feet.
- The event ends at 8:30 pm, and participants must be picked up no later than 8:45 pm. Any participant not picked up by that time will be escorted to the New Lenox Police Department (200 Veterans Pkwy, 815-485-2500 / 815-462-6100) where only their parent(s) or pre-designated individuals will be allowed to pick them up.
- No non-prescription drugs, alcohol, weapons, etc. are allowed at any time inside the Library building or on Library grounds.
- We will have treats at the event. Please let staff know if you/your child has any food-related allergies.
- You may speak with a staff member at the Library at any time during the event by calling or texting 815-655-2670.
